## METHODOLOGY

#### METHODOLOGY

### Home Care Study

#### Quantitative Market Research – Canada

This study was conducted from Feb 9<sup>th</sup> to Feb 11<sup>th</sup> 2024, among a sample of 1,000 respondents who are residents of Ontario and are members of Maru Blue's online panel. For comparison purposes, a probability sample of a similar size would have a margin of error of +/- 3%, 19 times out of 20.

Discrepancies in or between totals are due to rounding.

### Where & How is the Study Conducted?

The study included respondents from an online panel of eligible voters in Ontario, 55 years of age and older. The sample is weighted to regional, age and gender demographics, as per Statistics Canada.

## **EXECUTIVE SUMMARY**

67% of Ontario residents 55 years of age or older believe that professional caregivers such as personal support workers should be paid at the same rates regardless of whether they work in home care, long-term care or in hospitals, while 18% believe they should be paid differently based on their workplace setting and 15% were unsure (slide 13).

76% of Ontario residents 55 years of age or older believe that there is a role for the Ontario government to educate people about what to look for when accessing additional home care support, while 15% believe people should be responsible for who they decide to be their caregiver and 9% were unsure (slide 15).

Given their personal experiences and what they have read in the news lately, 86% of Ontario residents 55 years of age or older do not think the government has invested enough to prepare the home care system for increased senior population growth pressure, while only 3% think the government has invested enough and 11% were unsure (slide 21).

95% of Ontario residents 55 years of age or older said the government should be concerned or very concerned that Ontario's home care sector says the system needs \$411 million a year for the next three years to prepare for the growing number of seniors who will require care at home (slide 23).


95% of Ontario residents 55 years of age or older believe it should be a top or medium priority for the government to invest to attract more people to become home care PSWs (slide 25).

89% of Ontario residents 55 years of age or older were very concerned or somewhat concerned about availability of home care services in the province given the significant increase in demand that will come with the senior population growth, while 9% a little concerned or not concerned at all and 2% were unsure (slide 27).

# DETAILED FINDINGS

#### **i** Future housing plans


87% of the respondents said they plan to stay in their own home or apartment as long as possible, this number increased to 92% among male 65 years of age or older.

#### **i** Future housing plans


87% of the respondents said they plan to stay in their own home or apartment as long as possible, this number increased to 96% among residents in the city of Ottawa.

Nearly 9 out of 10 respondents said they prefer to stay at home if additional supports were available to them.




Q3 - If you were destined to move into a long-term care facility but additional support could be provided to keep you at home or living with a family member, would you still prefer to move into a long-term care facility?




Q3 - If you were destined to move into a long-term care facility but additional support could be provided to keep you at home or living with a family member, would you still prefer to move into a long-term care facility?

#### I Your first and second priorities to address home care funding issues



#### i Personal Support Workers pay rate


67% of the respondents said they believe PSWs should be paid at the same rates regardless where they work, this number goes up to 73% among females 65 years of age or older.

#### i Personal Support Workers pay rate


Two third of the respondents said they believe PSWs should be paid at the same rates regardless where they work. The numbers broke out roughly similar across the regions of Ontario.





#### i Offer tax relief or credits to seniors and families who fund home care services


9 out of 10 respondents said they believe the government should offer tax relief or credits to seniors and families who fund additional home care services for their loved one(s).

#### i Offer tax relief or credits to seniors and families who fund home care services



#### I Familiar/Not familiar with Ontario's home care system


16% of respondents said they are very familiar about Ontario's home care system, while only 7% of males 55-64 years of age said the same but 23% of females 65 years of age or older said the same.

#### I Familiar/Not familiar with Ontario's home care system


7% of respondents said they are not familiar at all about Ontario's home care system, while 14% of residents in the city of Ottawa said the same.

A whopping 86% of respondents said the government has not invested enough to prepare the home care system for the senior population growth pressure.





## i Concern about Ontario's home care sector needing \$411 million a year to prepare increased needs


56% of respondents said the government should be very concerned about Ontario's home care sector needing \$411 million a year to prepare increased needs. This number decreased to 42% among males 55-64 years of age and increased to 67% among females 65 years of age or older.

## i Concern about Ontario's home care sector needing \$411 million a year to prepare increased needs



#### i Government's priority to attract more home care PSWs

60% of respondents said it should be the government's top priority to invest to attract more people to become home care PSWs, this number increased to 70% among females 65 years of age or older and decreased to 46% among males 55-64 years of age.



#### **I** Government's priority to attract more home care PSWs



### I Concern about home care service availability giving population growth


